INSTRUCTIONS:

1. Please read the instructions given below very carefully. If the form is not filled as per instructions, the same will be rejected.
2. The nomination can be made by individuals only. Non individuals including society, trust, body corporate, partnership firm, Karta of Hindu Undivided Family, holder of power of attorney cannot nominate. A non-resident Indian can be a nominee on re - patriable basis
3. If the Shares are held jointly all joint holders shall sign (as per the specimen registered with the Company) the nomination form.
4. A nomination must be witnessed by two witnesses otherwise nomination form will be rejected.
5. A minor can be nominated and in that case the name and address of the Guardian shall be given by the holder.
6. Transfer of Shares in favour of a nominee shall be a valid discharge by the Company against the legal heir(s).
7. Only one person can be nominated for a given folio.
8. Details of all holders in a folio need to be filled; else the nomination will be rejected.
9. The nomination will be registered only when it is complete in all respects including the signature of (a) all registered holders (as per specimen lodged with the Company) and (b) the nominee/guardian.
10. Whenever the Shares in the given folio are entirely transferred or dematerialized, then this nomination will stand rescinded.
11. The intimation regarding nomination / nomination form shall be filed in duplicate with the Registrars & Transfer Agents of the Company who will return one copy thereof to the Shareholders.
