In compliance with the Applicable Circulars and the relevant provisions of the Companies Act, 2013 ("Act") and SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations"), the 4th AGM of the Company is being held through VC/OAVM. 

अमेरिकेत पीएच.डी करण्यास जाण्यासाटी डिसले यांनी जानेवारीत दीर्घकालीन रजा मागितली होती. परंत आवश्यक कागदपत्रे नसल्यामुळे शिक्षण विभागाने ती मंजर केली नव्हती. त्यानंतर तत्कालीन शालेय शिक्षण मंत्र्यांनी नियमबाह्य पद्धतीने रजा मंजुर करण्याचे आदेश अधिकाऱ्यांना दिल्यामुळे डिसलेंबाबत वाद सुरू झाला होता. र्डिसले यांनी अद्यापही विभागाकडे कागदपत्रे दिलेली नाहीत, असे अधिकाऱ्यांनी सांगितले.
