Consequent to the aforesaid allotment, the issued, subscribed and paid-up equity share capital of the Company stands increased from Rs. 23,31,32,680/- (Rupees Twenty Three Crores Thirty One Lakhs Thirty Two Thousand Six Hundred Eighty Only) divided into 4,66,26,536 (Four Crore Sixty Six Lakhs Twenty Six Thousand Five Hundred Thirty Six) to Rs. 23,33,72,680/- (Rupees Twenty Three Crores Thirty Three Lakhs Seventy Two Thousand Six Hundred Eighty Only) divided into 4,66,74,536 (Four Crore Sixty Six Lakhs Seventy Four Thousand Five Hundred Thirty Six) fully paid-up equity shares having a face value of Rs. 5/- (Rupees Five Only) each.
