## Sub: Request to provide demat account details for the purpose of crediting the Bonus Shares

This is with reference to the Postal Ballot Notice dated November 14, 2025 issued by the Company for seeking approval of the shareholders by way of Ordinary Resolution for the Issue of Bonus Shares. In this regard, we wish to inform you that the Securities and Exchange Board of India ("SEBI") vide its Circular No. SEBI/LAD- NRO/GN/2023/130 dated 23 May 2023 amended the provisions of Chapter XI of SEBI (Issue of Capital and Disclosure Requirements) Regulations, 2018 by inserting Regulation 294(6), wherein the allotment of shares in a Bonus Issue shall be made only in the dematerialized form.

In compliance with the above provisions, the Bonus Shares would be allotted to the shareholders in demat mode only. Accordingly, the shareholders holding the shares in physical mode are requested to provide their demat account number to Datamatics Business Solutions Ltd.
